THE ORGANIZERS

“*A world ruled by law, and not by force*” has been the World Jurist Association’s mission since its founding in 1963. A non-governmental organization in **special consultative status with the United Nations ECOSOC**, the WJA was created as free and open forum for judges, lawyers, law professors, students, and other professionals from around the world to cooperate in strengthening the Rule of Law and its institutions. Amongst its main activities are the biennial World Law Congress and the presentation of the World Peace & Liberty Award.

As a result of the Madrid Declaration of 2019, the **World Law Foundation (WLF)** was created as the executive arm for fundraising and organizing the main activities of the World Jurist Association. The Board of Trustees and the Advisory Board of the WLF are composed of prominent jurists and professionals, including former presidents and prime ministers, presidents of high courts, directors of prestigious institutions, lawyers, academics, and businesspeople.

THE WORLD LAW CONGRESS

The history of the World Law Congress is as extensive as the Association’s history. It began in 1963 in Athens, and has continued, almost unstoppable, every two years to this day. The **WORLD LAW CONGRESS DOMINICAN REPUBLIC 2025** will be the 29th edition and will take place on **May 4-6**, in **Santo Domingo**, capital of Dominican Republic.

The program of the Congress includes a series of simultaneous panels that will take place at **Universidad del Caribe’s** brand-new building. Throughout a full day, on May 5, more than 300 high-level speakers from 70+ countries will discuss current topics related to the Rule of Law, such as **IA regulation & ethics, cybersecurity, environment, freedom of expression, geopolitical events, constitutionalism, human rights, legal education and practice trends**, among many others.

On May 6, the Closing Ceremony will be held at a landmark building in Santo Domingo. During this ceremony, the *World Peace & Liberty Award 2025* will be bestowed to **Sonia Sotomayor**, Associate Justice of the **Supreme Court of the United States**. This award has been previously presented to Winston Churchill, René Cassin, Nelson Mandela, King Felipe VI of Spain, Ruth Bader Ginsburg, the Colombian society in hands of then President Ivan Duque, American civil rights leader Andrew Young, and to the European Commission in hands of President Ursula von der Leyen.

Who Attends?

The World Law Congresses serve as meeting point for leaders from a wide spectrum of our society. Remarkable personalities such as heads of State and Government, high representatives of supranational institutions (UN, OAS, EU, etc.), presidents and judges of national and supranational courts, prosecutors, academics, lawyers, activists, journalists, entrepreneurs, and students from all over the world converge in this leading event.

Side-Events

In the framework of the World Law Congress, the WJA, the WLF and other organizations and companies organize exclusive **side events**, which are a splendid opportunity to network with the personalities and speakers attending. 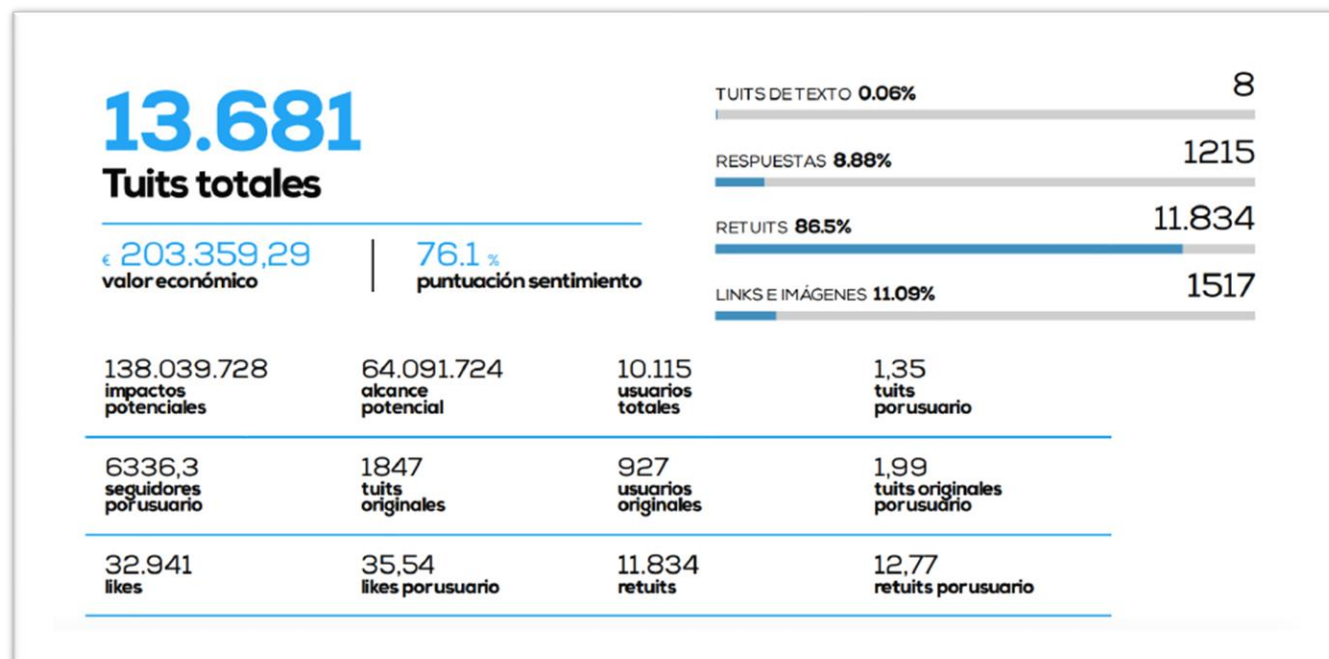

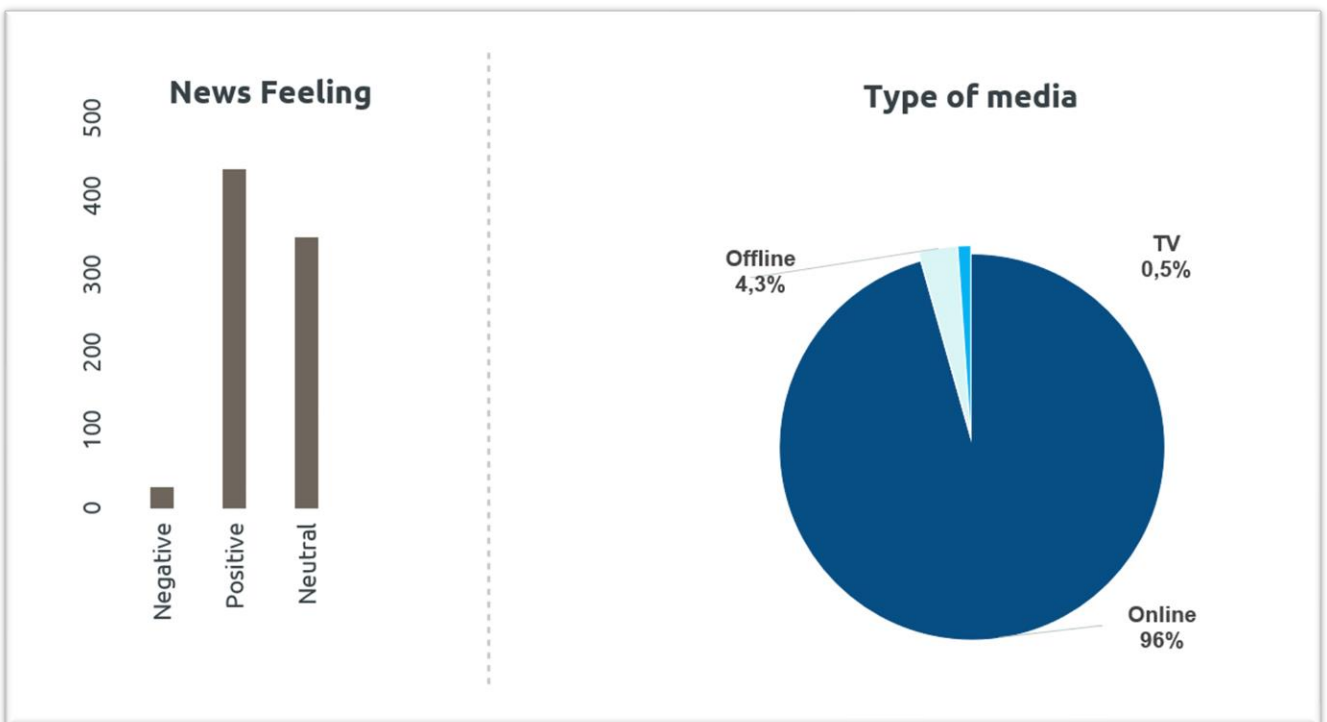
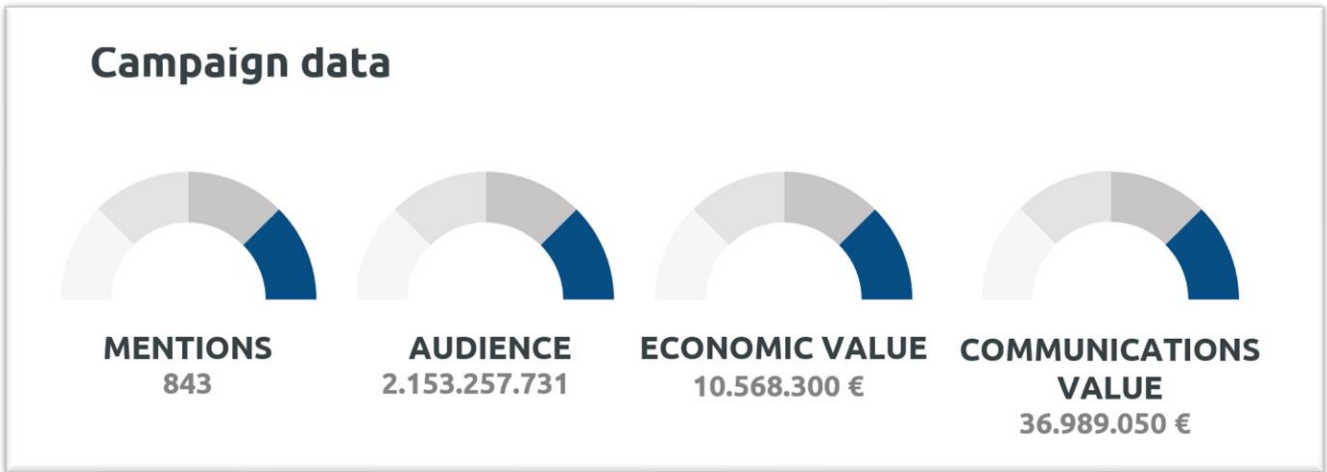
